
**PETITION FOR
INCENTIVE AWARDS**

Plaintiffs would show the court as follows:

1. Under the settlement agreement approved by the Court, Defendant Equifax agreed to pay Named Plaintiffs Franklin E. Clark and Latanjala Denise Miller incentive awards of up to \$1,000.00 each, subject to Court approval, for efforts and risks undertaken on behalf of the class.
2. This litigation is now four years old. During that time Clark and Miller have, among other things, remained in contact with and cooperated with Class Counsel, provided deposition testimony and other evidentiary information, attended a hearing, and been subjected to publicity and inconvenience in their roles as class representatives. In these circumstances, an incentive award of \$1,000.00 to each is reasonable and appropriate.
3. The undersigned has consulted with Defendant's counsel, and the Defendant does not oppose this petition.

WHEREFORE, Plaintiffs request that the court approve incentive awards of \$1,000.00 each to Franklin E. Clark and Latanjala Denise Miller.
